



**MEMORANDUM OF UNDERSTANDING

This Memorandum of Understanding is made on 2018 by and between

- I. Riau College of Pharmacy (STIFAR Riau) is an educational institution that has a vision and Mission in the field of pharmacist education. Managed by the University of Riau Foundation on Jalan kamboja Simpang Baru-Panam Kota Pekanbaru, Riau, Indonesia.(hereinafter referred to as “STIFAR Riau”)
- II. SHAHROUD UNIVERSITY OF MEDICAL SCIENCES is a public medical school located in Shahroud Country. It's a governmental funded university. Shahroud University of Medical Sciences and Health Services, Hafte Tir Square, Shahroud, Iran. (hereinafter referred to as “SHMU”)

Sekolah Tinggi IlmuFarmasi Riau (STIFAR) and Shahroud University Of Medical Sciences,seeking to improve understanding between their respective cooperation and collaboration in teaching and research activities to mutually beneficial their students, have agreed to sign this Memorandum of Understanding (hereinafter referred to as the “MoU”) as a first step toward achieving these shared goals.

Now Therefore Pursuant There To, the Parties hereby agree as follows:

Article1:

SCOPE AND FIELDS OF ACADEMIC COOPERATION

- (1) The present agreement is intended to encourage and develop programmes of cooperation and collaboration between the contracting parties to include the following activities:
 - a. Collaboration in teaching activities including: special short term academic program, teaching visit, student exchange, staff exchange as well as scholar exchange between universities
 - b. Joint research activities based on Natural Product Research, Traditional Medicine, Persian Medicine, Indonesian Herbal,Nanotechnology, Biotechnology, E-learning, Clinical Trial and Cohort Studies.

- c. Joint to organize the conferences, seminars or scientific meetings
- d. Participating in seminars, academic meetings and thesis juries
- e. Sharing and creation of academic materials and scientific publications
- f. Establishment of Joint Center for Educational Researching, Traditional Medicine and joint research papers with both affiliations.

- (2) The scientific cooperation shall initially be organized in Traditional medicine, Persian Medicine and Indonesian Herbal, nanotechnology, biotechnology, clinical trial and cohort studies
- (3) Each University shall nominate one of its members as its representative in charge of the cooperation program. It is the task of such member to act as principal contact for individual and group activities, and to plan and coordinate all activities within his/her University as well as the partner University

Article 2:



FINANCIAL ARRANGEMENTS

The activities mentioned in **Article 1** shall be financed according to the availability of funds. The Universities will endeavor to obtain from third parties (regional, national or international) the necessary funds for this cooperation and collaboration.

Article 3:

JOINT PROPERTY

- (1) The Parties agree that any intellectual property rights arising from or in connection with any programme or activity under this MoU, through and by the joint and collaborative efforts of both Parties shall be jointly owned and subject to any other terms and conditions as may be agreed upon in writing.
- (2) Both Parties shall acknowledge one another in any form of writing, publication or presentation based on research derived from the cooperative efforts of both Parties under this MoU, unless otherwise mutually agreed upon in writing by the Parties.

Article 4:

CONFIDENTIALITY

The Parties agree and undertake to keep confidential at all times any information or data that may be exchanged, acquired or shared in connection with any programme or activity conducted pursuant to this MoU save where the same is already in public domain.

Article 5:

DURATION AND TERMINATION



- (1) This MoU shall take effect on and from the date of execution of this MoU and shall continue to be effective for a period of five (5) years and may be extended for such further period as may be agreed by the Parties in writing.
- (2) Notwithstanding clause 5 (1) above, this MoU may be terminated by either Party giving written notice to the other at least six (6) months prior to the proposed date of termination.
- (3) Notwithstanding clause 5 (2) above, the provisions of this MoU or any other written agreement in respect of any on-going exchange programme or any other form of cooperative activity under this MoU shall continue to apply until their completion unless both Parties mutually agree in writing to the earlier termination of the programme or cooperative activity.

Article 6:

NOTICE

- (1) Every notice, request or any other communication required or permitted to be given pursuant to this MoU shall be in writing, in English and delivered personally or sent by registered or certified post via air mail or by courier or facsimile (which shall be acknowledged by the other Party) to the Parties at the address and facsimile number as stated below:
